## **Reminder: Media professionals invited to historic workshop on industry non-compliance with Medical Schemes Act provision**

Regulator of the medical schemes industry, the Council for Medical Schemes (CMS), remains concerned about the industry-wide non-compliance with the prescribed minimum benefit (PMB) provisions in the Medical Schemes Act.

Medical schemes and administrators are not providing PMBs in the way they should, blatantly disregarding the law. Some healthcare providers are taking unfair advantage of PMB provisions while beneficiaries seem to misunderstand their entitlements under PMBs.

In December last year the CMS published Circular 37 of 2009 detailing its concerns and asking industry to comply with PMB provisions or face punitive measures which may lead to the deregistration of medical schemes or the withdrawal or suspension of accreditation for administrators. Following an overwhelming response to the Circular and numerous meetings with stakeholders, the CMS has agreed to establish a PMB task team to ensure full compliance with PMB provisions in the industry going forward and to protect the rights of beneficiaries as far as their health and access to care is concerned. This PMB task team aims to draft a code of conduct by 30 June 2010 which will be binding on all industry players to ensure that PMB legislation is no longer flouted and beneficiaries are adequately protected.

### Reminder: what are PMBs?

Prescribed minimum benefits are benefits which are guaranteed to every beneficiary of a medical scheme under the Medical Schemes Act (Act 131 of 1998) and specifically Section 29(1)(o) and Regulation 7. All medical schemes must pay for all PMBs in full, regardless of the benefit option to which a beneficiary belongs. PMBs must be covered from a scheme's risk pool and not from its members' medical savings accounts.

PMBs are listed in the Medical Schemes Act. They cover the diagnosis, treatment, and care of three categories of medical conditions, namely:

1. any emergency medical condition;
2. the 270 diseases called the Diagnosis and Treatment Pairs or DTPs; and
3. the 25 chronic conditions on the Chronic Diseases List or CDL.
